

## 2024 COVERED CALIFORNIA FAQs Lucile Packard Children's Hospital and Lucile Packard Children's Hospital Medical Group Effective 01/01/2024

#### 1. Is Covered California the same as Medi-Cal?

No.

#### 2. Is Covered California a health plan?

No. Covered California (aka the Exchange) is an online marketplace where people can shop, compare, and purchase health insurance for individuals, families, and small business.

#### 3. Is there a health plan offered through Covered California that you recommend?

The needs of each individual seeking insurance coverage are unique. You should contact a Covered California representative at 1-800-300-1506 or go to their website <u>www.coveredca.com</u> for more information specific to you or your family.

## 4. Is Lucile Packard Children's Hospital contracted with any Individual and Family Plans (IFP) available for purchase on or off the Covered California Exchange for <u>hospital services</u>?

Yes, Lucile Packard Children's Hospital is contracted with the following plans:

- Aetna CVS Health HMO. Assigned medical group must refer and authorize all services. This plan is offered in Contra Costa and Alameda counties only.
- Blue Shield Trio HMO. Assigned medical group must refer and authorize all services.
- Valley Health Plan HMO. An approved authorization is required for all services at Lucile Packard Children's Hospital. This plan is only offered in Santa Clara, San Benito, and Monterey Counties only.
- Lucile Packard Children's Hospital does not participate in any Individual and Family Plan **PPO** plans, on or off the Covered CA Exchange.

#### 5. Is Lucile Packard Children's Hospital Medical Group contracted with any Individual and Family

# Plans (IFP) available for purchase on or off the Covered California Exchange for <u>physician</u> <u>services</u>?

Yes, Lucile Packard Children's Hospital Medical Group is contracted with the following plans:

- Aetna CVS Health HMO
  - Specialist Physician Services: For Aetna CVS Health HMO members, the selected medical group (John Muir Physician Network or Hill Physicians Medical Group) must refer and authorize all services provided by our Specialists.
  - Primary Care Services (PCP): Scroll to end of document for list of eligible Aetna CVS Health HMO PCPs.
- Blue Shield IFP PPO product (only Physicians located in Alameda and Contra Costa counties are innetwork)
- Blue Shield Trio HMO
  - Specialist Physician Services: For Blue Shield Trio HMO members, the selected medical group (John Muir Physician Network, Hill Physicians Medical Group, Santa Clara County IPA (SCCIPA), Brown and Toland Medical Group, Mills Peninsula Medical Group.) must refer and authorize all services provided by our Specialists.
  - Primary Care Services (PCP): Scroll to end of document for list of eligible Blue Shield Trio HMO PCPs
- Valley Health Plan HMO
  - Specialist Physician Services: Valley Health Plan must refer and authorize all services provided by our Specialists.
  - This plan is only offered in Santa Clara, San Benito, and Monterey Counties only.
  - We are not contracted to provide PCP services, except for patients enrolled with Santa Clara County IPA (SCCIPA). The following PCPs in SCCIPA participate as PCPs for VHP Covered California.

# 6. My child comes to Lucile Packard Children's Hospital for <u>transplant related services</u>. Which plans include Lucile Packard Children's Hospital as in-network?

LPCH and its transplant Physicians are contracted with the following Covered California plans on and off the Exchange for all transplant related services including evaluation, pre-transplant, transplant procedure, and post-transplant care:

- Blue Shield Trio HMO\*
- Blue Shield Small Business Plan HMO/PPO (SHOP)\*
- All Anthem Covered California plans including, but not limited to, Anthem Blue Cross EPO\*\*

\* Physician services under the HMO may be out-of-network.

\*\* Anthem may require a network exception based on your plan. Network exceptions are ultimately the decision of your plan to allow services at Stanford Health Care.

LPCH and its transplant Physicians are contracted with the following Covered California plan on and off the Exchange for **transplant procedure and limited post-transplant services only. Evaluation, pre-transplant and extended post-transplant care are not contracted.** 

• Blue Shield IFP PPO (excludes Kidney Transplant\*)

\*Kidney Transplant is out-of-network for evaluation, pre-transplant, transplant procedure and post-transplant services.

# 7. I purchased a health plan through Covered California which is not mentioned in one of the other FAQ's. Is my plan accepted at Lucile Packard Children's Hospital?

Lucile Packard Children's Hospital and Physicians are out-of-network with your plan, but we encourage you to call the member service telephone number on your insurance card to confirm.

## 8. I have a Covered California Small Business Plan (SHOP.) Is my plan accepted at Stanford Health Care?
